Requirement	Details
1. Business Eligibility	 Must be a licensed business: contractor, designer, builder or showroom owner Valid business registration and tax ID
2. Showroom / Sales Channel	 Operate a physical or online sales platform Maintain product displays and follow brand integrity
3. Inventory Agreement	 Oscar retains product ownership until sold Minimum display quantities may apply by category
4. Revenue Sharing	 Commission or revenue split based on MSRP or wholesale rates Payouts issued monthly after verified sales
5. Reporting & Tracking	Submit bi-weekly or monthly sales reportsUse Oscar-approved tracking tools or software
6. Returns & Damage	 Damaged/unsold items handled per agreement terms Consigner responsible for safe handling
7. Branding & Marketing	Must follow Oscar brand guidelinesCo-branded campaigns available upon request
8. Agreement Term	 Initial term: 6–12 months, renewable 30-day written notice required for termination

Step	Description

2. Display Setup	- Receive branded sample boards, top-performing products and tags at no cost —or use your own showroom displays.
3. Start Selling	 Offer materials at wholesale discounts starting at 25%. Pay only when products are sold.
4. Fulfillment by Oscar	- We handle inventory, shipping, and restocking. Materials are delivered directly to your client or job site.
5. Sales Reporting & Payouts	- Report sales regularly and get paid every 7–14 days , with full support from our U.Sbased team.
